- a. Veteran's Tribute Norm Combs and Mike Switzer
  - i. Nothing new to report. Shannon did report that the solar lights on the flagpoles had been vandalized. They have been replaced and now positioned higher on the flagpoles to make them harder to get too.

- a. Christina "Kiki" Claphan Memorial Playground Shannon Davies
  - i. Shannon and Dick Tuttle have had preliminary meetings for this project with Lamp Rynearson, the City's On-Call Engineering firm. Project timelines will be put in place. We are looking at project completion in late fall of this year so that there is little impact to the park and shelter rentals while we are still in the busy season.
- b. Football Facility Improvements Shannon Davies
  - i. The perimeter posts running parallel with Old 40 Hwy. have been installed.

A vehicular gate has also been installed. The posts were installed about 5-feet apart which is too narrow for vehicles to drive between. With the barrier, this will prevent vehicles from accessing the parking lot and adjacent grassy fields afterhours and doing donuts/rutting-up the park and breaking into park buildings.

  - i. Shannon provided the board with a copy of the 2022-2026 CIP. The board reviewed those projects that have been completed this past year, what is scheduled this year, and the next several years.
