  - i. Shannon stated that he has been in touch with Patti Reed, Grant Administrator with Missouri State Parks regarding our LWCF application. She is now stating that the grant awardees will not be notified until September. All LWCF applications are held-up right now with the National Park Service. Our application for funding for the Armstrong Park playground is currently under review by the Osage Nation pending approval of the Cultural Resources Survey we submitted. Patti stated that all 2020 application awardees were



notified a year late in 2021, which looks like is going to happen with our 2021 application. We will have to re-budget project dollars to the 2023 budget as this project will not be completed this year as anticipated. Shannon provided a letter of explanation by Patti Reed to the board.
