- Mayor Todd asked to have further discussion/clarification on a few items on this ordinance; the intent is still valid, but with the distrust in government in general they wanted to clarify
- Mr. Murphy stated this puts what was in practice into an ordinance this is permitted construction and not cutting your grass, etc. Building permits have been updated since then and it is highlighting permitted work; The law enforcement side of this was discussed with Chief and Captain and how these calls would be handled
- Mayor Todd asked if someone were to call for a peace disturbance if this would be a signed complaint – the Police are responding to these calls with or without this legislation
- Chief Turner stated officers handle hundreds of these a year with or without the
  ordinance, and the officers are able usually to diffuse the situation most of the
  time and this would be a tool at their disposal if needed for repeat issues and this
  would help them do their jobs from time to time
- Alderman Bray asked who a summons would be issued to; Chief stated whoever
  is on site will be accountable for the violation they have worked to make sure
  the permit is on site as a safeguard and is helpful for the officer to have; the job
  foreman or whoever is named would be responsible
- Alderman Arnold stated he believes this ordinance should still include language
  of "permitted commercial construction" and feels this would go a long way in
  clarification for the future and passed out an example of what this could look like.
- Alderman Knox stated he thinks this would go a long way after he talked with his neighbor after the meeting that this was passed
- Mayor Todd stated there is a definition of the policy from staff
- o Mr. Trosen stated this has been the policy and clarification has been added to the permit applications – also added verbiage related to residential maintenance that an after-hours permit is not required. He stated there are new residential subdivisions going in and this is why the commercial is not in the current description as they are considered residential. To many this kind of construction is disturbing to those that
- Alderman Knox stated he feels it is confusing to not understand what is commercial vs. residential construction and what falls under this policy
- Alderman Mills stated he didn't receive any calls on this and feels there were misleading things on social media that caused this to be an issue
- Alderman Arnold stated he copy/pasted the verbiage from the ordinance and didn't think he was being misleading and stated those that read the ordinance for themselves had concerned.
- Alderman Skinner stated 50 years from now Chief and Mr. Trosen are no longer in office and new people are in charge, and police are called out to a job site, is there somewhere saying only permitted work/after hour work permit is where the confusion is; Mr. Trosen confirmed this is part of the permit application and not in

the ordinance; Alderman Skinner is concerned for the future enforcement/understanding of the ordinance. If "permitted work" is not put into the ordinance.; He stated "permitted work" could be added to the ordinance or could be clarified somewhere else if it could be defined on what excavation's definition (etc.); he does not support the suggested verbiage from Alderman Arnold. He stated reading the ordinance, building construction doesn't mean permitted work to those reading it

- Alderman Bray asked if there is a current peace disturbance ordinance; Mr. Murphy stated yes, a general one and that there are not hour restrictions; then Alderman Bray offered an example related to loud music; Chief Turner stated if determined there is a victim and a complaint is filed and they will sign the complaint and go to court; Alderman Bray seems if noise from music or construction there is a tool for officers; Alderman Bray stated the only difference is possibly the ordinance violated and it is up to the officer to determine which one will go on the ticket and potentially the fine associated; Alderman Bray feels this issue is clear
- Alderman Skinner asked if they could motion to update the ordinance to add permitted work to clarify the ordinance further; Mr. Murphy stated the board can direct staff to make an update or ordinance change; Alderman Skinner stated loud music is an obvious disturbance, but a hammer, no one is intentionally doing anything wrong and this would provide the officers would have a tool to deal with it. Alderman Bray feels they are in violation anyway and if the hammering at noon is disturbing him, it is disturbing the peace
- Alderman Arnold stated noise before a certain hour and after a certain hour are different things and the racetrack runs until 11 and this could fall under the work hours; Mr. Murphy stated the track is covered by a cup; Alderman Arnold feels there are conflicting ordinances; he feels people have a general understanding that up to a certain hour noise is understood, but after a certain time it is quiet time; Alderman Skinner asked if he's suggesting people violate their work permit
- Alderman Skinner asked if they could motion to update the ordinance to add permitted work to clarify the ordinance further
- Alderman Arnold stated a work permit can be revoked; Alderman Skinner stated this is a tool for officers and someone hammering on Saturday at noon is different; Alderman Arnold feels noise is noise and they already have a tool in place to help with this
- Chief Turner stated officers already respond to these calls hundreds of years and they deescalate and diffuse situations like this and generally will not write a ticket, but this would be a tool they can use if necessary
- Alderman Mills asked if the way it is written is good with him; Chief Turner stated he's comfortable deploying this ordinance and understands; Alderman Mills asked if adding work permit if he'd be satisfied

#### **ITEM XXI: Mayor Report**

- Shared his congratulations to everyone on being elected
- An interchange possibility at Tyer Road was in the paper and then Blue Springs approached Mayor, Alderman Mills, City Administrator Murphy and Deputy City Administrator Osenbaugh about this possibility to help relieve truck traffic off Adams Dairy Road.
- This would be East of the Brass Armadillo and there are houses on Tyer Road and their concern was this would potentially condemn houses for an interchange; they didn't think there would be any condemnation. Their state rep (different than Grain Valley's state rep) got \$300,000 for a traffic/environmental impact study and they are in need a letter of support from the City of Grain Valley for this project; They also want us to cost-share this project per the letter from State Rep Sander and Mayor shared that we would be more likely to cost share on something between us and Oak Grove as it is more beneficial for us. Mayor Todd asked if they expected us to pay for any of this; they said no, but the letter doesn't read that way and it looks like 50/50 cost share for the whole down the line. They also would not be improving Tyer Road as part of this. Mayor Todd is asking the board if they would like to provide a letter of support.
