roadmap to an occupational license

Step 1: Zoning



BUSINESS IN CITY LIMITS

- Ensure premises of business complies with zoning regulations
- Home based businesses must also meet guidelines and regulations
- For more zoning and use questions, call:

Step 2: Sales Tax



DIRECT SALES OF MERCHANDISE

- Sales tax must be collected if any component of direct sales occurs within city limits
- A Sales Tax ID must be established & provided to the City
- Apply for an ID by scanning the QR Code.



Step 3: City License



APPLY FOR A LICENSE

- License applications are filed with the City Clerk - approval process may take up to 15 days
- Apply for a permit/license by scanning the QR Code



Special Considerations



Mobile Food Units (Food Trucks)

Annual Occupational License required

- Sanitary Inspections required (provided by Jackson County)
- Allowed to park at:
 - Private property zoned for retail sales - with permission from property owner
 - Parking lots in a Residential District with permission from owner



Landlords

Annual landlord registration permit required

- If you rent or lease one or more properties, you must register as a landlord
- A local contact must be provided during the registration process



Solicitor/Peddler

PEDDLER & SOLICITOR PERMIT REQUIRED

- A 120-day permit can be issued by Grain Valley Police Department
- Fee is waived with valid Occupational License



DOING BUSINESS IN GVMO

Those applying for an occupational license within City limits may be subject to further review. Approval considerations include, but are not limited to zoning, building, municipal codes, and pending court cases. Licensing period is July 1st through June 30th of each year.

fees are non-refundable and not prorated
