Dear Resident:

The City of Grain Valley has adopted regulations to assist in providing a safe and inviting community for our citizens. Your cooperation is essential to help maintain the quality of our neighborhoods and promote a positive image for our community. As part of an increased effort to provide better animal control services to citizens within Grain Valley, we ask that all pet owners license their pets with the City of Grain Valley. Animal licenses are important as they allow Animal Control to identify and return lost animals to their owners, verify that animals within the City have been properly vaccinated against rabies, and determine the amount of resources needed for improved animal services to our residents

Per city ordinance, the Animal License is to be renewed yearly between January first (1<sup>st</sup>) and February first (1<sup>st</sup>). The amount owed per animal is as follows:

- Dog/cat \$10.00 per year (\$10.00 late fee if after February 1)
- Primates \$100.00 per year (\$25.00 late fee if after February 1)
- Ferrets \$100.00 per year (\$25.00 late fee if after February 1)
- Vietnamese Potbelly Pigs \$100.00 per year (\$25.00 late fee if after February 1)

As an animal owner, it is your responsibility to ensure your animal(s) are licensed **each year** by February 1st. Enclosed is the animal license application for your convenience. Please bring completed application, your animal(s)' current rabies vaccination records, and the appropriate fee per animal to City Hall to obtain the metal license tag(s) if a new tag is needed.

If you are unable to comply by February 1<sup>st</sup>, please contact the Police Department before then to make arrangements to license your animal(s). Failure to license your pet can result in a citation and court appearance. Thank you for your cooperation with this matter.
